



Patient Eligibility

- Physician statement of terminal diagnosis with 6 month or less prognosis;
- Residential Care and Acute Care settings available;
- Medicare, Medicaid, TriCare and private insurances accepted upon approval;
- Physicians, nurses, ministers, family members, social workers or patients may refer subject to eligibility screening.

Three Levels of Care

- **General Inpatient Care/Acute Care:** provides pain control, symptom management, medication adjustment, observation, psychosocial monitoring. Anticipated stay: a few days; usually less than one week.
- **Respite Care:** relieves family care givers from 24-hour/day patient care. Maximum stay: 5 days. Patient returns home with a rested family caregiver.
- **Residential Care:** patients must be hospice eligible without an appropriate situation to receive care at home but able to have input into their own care. Average stay: 3 - 4 months as long as patient remains hospice eligible.
